### **Product Master Data**

The following tables list the fields in Product Master Data for syncing product information for all US Target Markets to Product Information Manager to support the US DSCSA Saleable Returns requirements. Some fields stated here as required do not display the red asterisk in the UI but are required for syncing to Product Information Manager.

#### **Product Information Fields**

Data Status	Whether the product data is active within TraceLink.  CSV Element Header: DataStatus  A Required for all countries.	<ul> <li>Active – The data can be used in messages and UI functions, and TraceLink pulls the data when necessary.</li> <li>Inactive – The data cannot be pulled for other functions within TraceLink.</li> <li>Must be Active to sync the product entry to Product Information Manager.</li> </ul>
Item Status	The product's commercial status.  CSV Element Header: ItemStatus  Required for all countries.	<ul> <li>Released – The company approved the product for commercial release.</li> <li>Alternate items available – The company has alternate items that can take the place of this product.</li> <li>Phase out – The company phased out this product from production and sale.</li> <li>Items no longer stocked – The company does not currently stock this product.</li> <li>Withdrawn – The company removed this product from the market.</li> <li>When the product has an Export From Country of India, the only Item Status options are Released, Items no longer stocked, and Withdrawn.</li> </ul>

Primary Item Code	The radio button indicates the primary item code used by this company. Country Market Code	Two-letter ISO 3166-1alpha-2:1997 Country Code of the Target Market's country.  A Required for all countries.	⚠ Must include a target market that is also defined for syncing on the Product Information Manager Data Rules screen in Management to sync the product entry to Product Information Manager.
Product Type	Type of product. Traceability regulations differ depending on the product type (e.g. over-the-counter drugs do not fall under DSCSA regulations in the US). For informational purposes only, not compliance reporting.  CSV Element Header: CountryMarketProductType	<ul> <li>Bulk Pharmaceutical – A product that is the main active ingredient in one or more pharmaceutical formulas (e.g. antibiotics).</li> <li>Derivative Product – A product derived from another chemical compound.</li> <li>Food Supplement – A medicine available over the counter that is used for health and nutritional benefits.</li> <li>Medical Device – A device developed and used for a medical purpose.</li> <li>Nutritional Product – A specific class of over-the-counter product use for health and nutrition benefit.</li> <li>OTC Drug – A medicine available over the counter.</li> <li>Prescription Drug – A medicine available by prescription only.</li> </ul>

Product Origin	How the company acquires the product. ### **Packaging Information Fields**
